USE AND DOSAGE

MAINTENANCE: 5 LITRES OF BIOZONO PER 100 CUBIC METERS OF WATER EVERY 7-10 DAYS DEPENDING ON THE USE OF THE POOL AND ON THE REFIL OF WATER.

TO BE USED IN COMBINATION WITH ACQUA MADRE, BIOSAN AND BIOACID.

HANDLING AND STORAGE

HANDLE WEARING RUBBER GLOVES AND SAFETY GOGGLES. STORE AT ROOM-TEMPERATURE IN A VENTILATED PLACE AND PROTECTED AGAINST DIRECT SUNLIGHT. AVOID CONTACT WITH ORGANIC MATTER. STORE THE PRODUCT AWAY FROM HEAT SOURCES. DO NOT PUT UNUSED QUANTITIES OF PRODUCT IN THE ORIGINAL CONTAINER. KEEP CONTAINERS IN VERTICAL POSITION AND REGULARLY CHECK THAT THE VENT HOLES IN THE BUNG WORK PROPERLY.

FIRST-AID MEASURES

SKIN: REMOVE ANY CONTAMINATED CLOTHING IMMEDIATELY AND WASH WITH COPIOUS AMOUNTS OF FLOWING WATER.
