#### CHARACTERISTICS:

#### USE AND DOSES:

#### EXPOSURE CHECK/INDIVIDUAL PROTECTION

BREATHING PROTECTION: BREATHING EQUIPMENT IS ESSENTIAL IN THE CASE OF EXPOSURE TO DUST (SAFETY DUST-RESISTANT MASK)

HAND PROTECTION: RUBBER GLOVES

EYE PROTECTION: FULL PROTECTION GOGGLES  
BODY PROTECTION: PROTECTIVE CLOTHING, BOOTS  
ADDITIONAL MEASURES: BOTTLES FOR EYE RINSING

#### HANDLING AND STORAGE

HANDLING:  
ONLY USE IN WELL VENTILATED ROOMS TO PREVENT DUST GATHERING IN NARROW SPACES  
AVOID CONTACT WITH THE SKIN AND EYES  
THE DUST CAN FORM EXPLOSIVE MIXTURES WITH THE AIR  
STORE FAR FROM EXPLOSIVE SUBSTANCES  
STORAGE:  
KEEP IN A DRY, FRESH, WELL-VENTILATED PLACE  
PROTECT AGAINST CONTAMINATION  
PRESERVE IN ORIGINAL CONTAINERS  
STORE FAR FROM EXPLOSIVE MATERIAL

#### FIRST AID MEASURES

GENERAL INFORMATION: REMOVE FROM EXPOSURE AREA, HAVE THE PERSON LIE DOWN, DO NOT GIVE ANYTHING TO THE PERSON IF THEY HAVE FAINTED.

INHALATION: BRING THE PERSON INTO THE OPEN AIR. MAKE USE OF OXYGEN OR ARTIFICIAL RESPIRATION IF NECESSARY. CONSULT A DOCTOR

CONTACT WITH EYES: THOROUGHLY RINSE WITH PLENTY OF WATER FOR AT LEAST 15 MINUTES AND THEN CONSULT A DOCTOR. RINSE, KEEPING YOUR EYE WIDE OPEN

CONTACT WITH THE SKIN: WASH WELL WITH WATER. IMMEDIATELY REMOVE CONTAMINATED CLOTHING AND SHOES AND IF THE SKIN RASH PERSISTS CONTACT A DOCTOR.

SWALLOWING: DO NOT TRY AND VOMIT. IF CONSCIOUS, DRINK PLENTY OF WATER. CONSULT A DOCTOR

CONTAINS SODIUM PERSULFATE > 95%, CO-FORMULANTS.
