#### **USE AND DOSAGE :**

INITIAL DOSAGE:

MEDIUM-HARD WATER: 30-60 g/m<sup>3</sup>

HARD WATER: 60-100 g/m<sup>3</sup>

MAINTENANCE DOSAGE:

ACCORDING TO THE DAILY CHANGE OF WATER, IT IS RECOMMENDED TO ADMINISTER 5 - 10 g/m<sup>3</sup> EVERY 2 - 3 DAYS.
