SPECIFIC WARNINGS:

WHILE "I SALI DELLA VITA" SOLUTIONS ARE LESS CORROSIVE THAN OTHER SIMILAR SODIUM CHLORIDE BASED SOLUTIONS (COMMON SALTS) WITH THE SAME CONCENTRATION LEVEL, THE PRODUCT SHOULD ONLY BE USED IN SWIMMING POOLS AND CIRCUITS SUITABLE FOR WORKING WITH HIGH SALINE LEVELS; ITS USE IS, THEREFORE, ONLY RECOMMENDED IN POOLS WITH PLASTIC CIRCUITS, FIBREGLASS AND LINER WALLS AND WHERE ANY METAL ACCESSORIES ARE MANUFACTURED WITH ANTI-CORROSIVE MATERIALS (FOR EXAMPLE AISI 316L STEEL).

IN POOLS WITH CARTRIDGE FILTERING SYSTEMS, CHECK THE COMPATIBILITY OF THE SCENT WITH THE KIND OF CARTRIDGE USED.
