CHARACTERISTICS

SPECIAL STABILISING PEROXIDE BASED FORMULA TO BE USED TO CARRY OUT SHOCK TREATMENTS OF SWIMMING POOL WATER. IT GUARANTEES THE COMPLETE DESTRUCTION OF BACTERIA AND ORGANIC SUBSTANCES FOUND IN THE POOL.

USE AND DOSES

ONLY FOR SHOCK TREATMENT (BREAK POINT DISINFECTION)

DOSE 25 TO 50 GRAMS OF THE PRODUCT PER CUBIC METER OF POOL WATER DIRECTING INTO THE POOL. WAIT 24 HOURS BEFORE RE-USING THE POOL.

IN THE EVENT OF STRONG ALGAE ATTACKS AND BACTERIAL POLLUTION, WE RECOMMEND YOU ADD A BIOSAN SHOCK TREATMENT WITHIN THE REASON OF 50 cc/m3 = 5 L/100 m3 TO THE BIOSHOCK TREATMENT

TO CHECK THE CONCENTRATION OF REAGENT IN THE POOL, USE THE DPD METHOD OR A SUITABLE KIT

HANDLING AND STORAGE

STORE AT ROOM TEMPERATURE AND AWAY FROM DIRECT SUNLIGHT. AVOID CONTACT WITH ORGANIC MATERIAL. PLACE THE PRODUCT AT A DISTANCE FROM HEAT SOURCES. DO NOT RETURN UNUSED AMOUNTS OF THE PRODUCT TO THE ORIGINAL CONTAINTER.

FIRST AID MEASURES

IMMEDIATELY REMOVE ANY CONTAMINATED SKIN-CLOTHING AND WASH THOROUGHLY UNDER RUNNING WATER

EYES: IMMEDIATELY AND THOROUGHLY WASH WITH RUNNING WATER KEEPING EYELIDS OPEN. IF NECESSARY, SEE AN EYE SPECIALIST AND TAKE THE LABEL WITH YOU.

SWALLOWING: RINSE YOUR MOUTH THOROUGHLY AND DRINK WATER. CONSULT A DOCTOR AS SOON AS POSSIBLE.

VAPOUR INHALATION: REMOVE THE PERSON IN QUESTION FROM THE CONTAMINATED AREA. IF BREATHING IS IRREGULAR OR THE PERSON IS NOT BREATHING, PERFORM ARTIFICIAL RESPIRATION. SEE A DOCTOR AS SOON AS POSSIBLE.
