IDENTIFICATION OF THE SUBSTANCE:

IT RAISES WATER pH VALUE WITH BUFFER EFFECT.

USE AND DOSAGE :

IT IS RECOMMENDED TO PREVIOUSLY ADD THE PRODUCT TO A BUCKET OF WATER IN 10% DILUTION (1 KG OF PRODUCT EVERY 9 LITRES OF WATER) AND THEN TO TRANSFER THE SOLUTION INTO THE POOL POSSIBLY BY MEANS OF AN AUTOMATIC METERING PUMP. AVERAGE DOSAGE: 200 – 300 CC IN 100 M³ OF WATER IN ORDER TO RAISE pH VALUE BY 0.1 UNITS.
