SPECIAL DE-SCALANT AGENT FOR THE REMOVAL OF IRON - SILICA - SULPHATE RESIDUES

IDENTIFICATION OF THE SUBSTANCE:

THE BALANCED AND SPECIALLY CONCEIVED FORMULA OF F 33 ENABLES IT TO REMOVE RAPIDLY EVEN THE TOUGHEST RESIDUES OF IRON-SILICON-SULPHATE SCALE FORMATIONS. THE PRESENCE OF CORROSION INHIBITORS PRESERVES METAL PARTS FROM AGGRESSIVE ATTACKS. IT IS ADVISED, HOWEVER, NOT TO USE THE PRODUCT ON SUCH PARTS. BECAUSE OF ITS HIGH DESCALING EFFECTIVENESS, IT IS RECOMMENDED TO RINSE THE PRODUCT OFF WITH COPIOUS AMOUNTS OF WATER AFTER RESIDUE REMOVAL.

USE AND DOSAGE:

DEPENDING ON THE CASE, THE PRODUCT CAN BE USED PURE OR IN 30 - 50% DILUTION, ALLOWING IT TO ACT FOR THE SPECIFIED AMOUNT OF TIME. THEN, ALWAYS RINSE -OFF ITH COPIOUS AMOUNTS OF WATER.
