IDENTIFICATION OF THE SUBSTANCE:

WINTER P HAS BEEN FORMULATED TO AVOID THE FORMATION OF WINTER-TYPICAL CALCAREOUS AND SLIME DEPOSITS IN OUTDOOR SWIMMING POOLS. IT ENABLES A RAPID AND PERFECT CLEANING OF THE POOL WALLS BEFORE SEASONAL FILLING.

USE AND DOSAGE:

ADD WINTER P INTO POOL WATER POINT OF MAXIMUM AGITATION IN ORDER TO ENHANCE ITS HOMOGENEOUS DISTRIBUTION.

MEDIUM-HARD WATER DOSAGE: 30 cc/m^3 HARD WATER DOSAGE: $40\text{-}50 \text{ cc/m}^3$ VERY HARD WATER DOSAGE: $50\text{-}100 \text{ cc/m}^3$
