IDENTIFICATION OF THE SUBSTANCE:

CONTROL METAL HAS BEEN FORMULATED IN ORDER TO AVOID THE PROBLEMS ORIGINATING FROM CALCAREOUS HEAVY METAL DEPOSITS SUCH AS COPPER, IRON, MANGANESE ETC...

USE AND DOSAGE:
